

PRIVACY POLICY

The privacy of our customers and partners is important to us. Our privacy policy complies with the new EU General Data Protection Regulation, which came into effect on May 25, 2018.

1. General information

STUK International Oy is a Finnish company. Our address is Laippatie 4, FI-00880 Helsinki.

This is the privacy policy of our company. When you visit our website or purchase our services, we may process personal data that pertains to you. The procedure regarding this is described below.

We use your personal data according to the limitations provided by the Finnish Data Protection Act and the EU General Data Protection Regulation 2016/679 (GDPR).

2. Data, their purpose of use, and the grounds for collecting data

When you purchase our services and/or when we engage in cooperation, we may process your personal data, such as your name and contact information (including your address, email address, and telephone number, for example). This is done so that we can contact you when necessary.

Your data is also processed partly because doing so is necessary to fulfill the agreement, and partly because it is necessary to ensure effective communication with you and to provide you with the agreed services.

We do not harvest, collect or analyze information regarding the use of our website, its traffic or functions. Using our website does not require registration.

If we decide to engage in direct marketing, we will request your consent for it separately.



3. Sharing your data

We do not share your data with third parties, except in situations where we are required to do so by law, or if we have your specific consent to do so.

4. Location of your data

We store your personal data on servers located safely within the EU/EEA. As we take data protection very seriously, your personal data is not transferred outside of the EU/EEA. In certain cases, for example when we provide services outside of the EU/EEA, it may however be necessary to transfer your personal data outside of the EU/EEA. In practice, the tendering procedure mentioned above means enclosing the information of the CV you have provided to us with the tender materials.

5. Storage and deletion

We delete the personal data once all purposes for the processing of personal data have been fulfilled and the deletion of data is allowed by legislation and/or regulations.

You may request access to your personal data or their deletion by contacting us in the manner described below.

6. Your rights

At your request, you are entitled to access your personal data stored or otherwise processed by us. You are also entitled to the rectification of incorrect personal data, and, in some cases, you are entitled to restrict our right to process your personal data or demand us to delete your personal data. You can withdraw your consent regarding the processing of your personal data at any time.

If you have any objections regarding the processing of your personal data, we ask that you contact us. Please address all such requests in accordance with the instructions included in this privacy policy. Where necessary, you have the right to lodge a complaint with the Finnish data protection authority.

7. Updates and amendments

This privacy policy may be updated or amended. When we amend this privacy policy, we will include the date on which the policy was updated in this document. If this policy or the manner in which we use your personal data is changed substantially, we will notify you either by including a visible notification of such changes before making them, or by sending a notification to you directly.
